GASB 34/35 beginning in FY 2009-10 requires allocation of expenses for operations and maintenance, depreciation, and interest across functional categories. For FY 2009-10 and later, amounts are reported to IPEDS with these allocations. To make data comparable to prior years, amounts are allocated based on the 4-year weighted average of proportional distribution across functional areas in 2009-10, 2010-11, 2011-12, and 2012-13.
